Did you know:

- Only one naloxone prescription is dispensed for every 70 high-dose opioid prescriptions.
- States with co-prescribing mandates have seen an estimated 16% reduction in overdose fatalities.²
- 66% of the 68,000 overdose fatalities in one year had at least one opportunity for intervention.³
- Opioid overdose reversal medication access varies widely dispensation rates differ more than 25x between U.S. counties, indicating a need for greater consistency.4

- Deliver streamlined real-time patient notifications to providers when patients qualify for overdose reversal medications per CDC guidelines or state mandates.
- Ensure care continuity and receive PDMP-specific prompts supporting co-prescription at point of care.




